BE IT ORDAINED BY THE CITY OF ST. LOUIS, AS FOLLOWS:

SECTION ONE.

There is hereby appropriated and set apart out of the Interest and Sinking Fund Revenue the sum of Nine Million, One Hundred Five Thousand, One Hundred Ninety-Five Dollars (\$9,105,195) for the payment during the Fiscal Year of INTEREST, EXPENSES AND PRINCIPAL due on the CITY BONDED INDEBTEDNESS, as hereinafter detailed.

SECTION TWO.

Under and by authority of Section 3 of Article XVI of the Charter, there are hereby levied the following rates of the City taxes for the year 2025 on the assessed valuation of all real and personal property within the City made taxable by law for State purposes, to wit:

(1) For municipal purposes, Ninety-Nine and Forty Hundredths cents (\$.9940) on each

One Hundred Dollars (\$100.00) assessed valuation of real and tangible personal property.

(2) For county purposes within the City, Thirty-Four and Seventy-Seven Hundredths cents (\$0.3477)

on each One Hundred Dollars (\$100.00) assessed valuation of real and tangible personal property.

(3) For hospital purposes, Ninety-Nine and Ninety-Five Hundredths cents (\$0.9995) on each One Hundred Dollars (\$100.00) assessed valuation of real and tangible personal property.

(4) For public health purposes, Two Hundred Hundredths cents (\$0.0200) on each One Hundred Dollars (\$100.00) assessed valuation of real and tangible personal property.

(5) For recreation purposes, Two Hundred Hundredths cents (\$0.0200) on each

One Hundred Dollars (\$100.00) assessed valuation of real and tangible personal property.

SECTION THREE.

FUND 1000 GENERAL FUND

There is hereby appropriated and set apart the sum of Six Hundred Seven Million, Four Hundred Ten Thousand, One Hundred Eighty-Nine Dollars (\$607,410,189) which appropriation consists of Five Hundred Sixty-Four Million, Two Hundred Eighty-Five Thousand, One Hundred Eighty-Nine Dollars (\$564,285,189) from Municipal Revenue Funds, Eight Million, Two Hundred Thousand Dollars (\$8,200,000) from the State Gasoline Tax with any amounts over this total allocated to the Capital Improvements Fund, Three Million, Five Hundred Eighteen Thousand Dollars (\$3,518,000) from Motor Vehicle Sales Taxes, Three Hundred Thousand Dollars (\$300,000) from the Improved Wharf Fund for the DEPARTMENT OF STREETS, Seven Million, Eight Hundred Thousand Dollars (\$7,800,000) from the Tourism Fund for the CERVANTES

1 CONVENTION CENTER, Eleven Million, Two Hundred Thousand Dollars (\$11,200,000) from
2 the City Convention and Sports Facility Trust Fund, for the purposes set forth in §67.657.10
3 R.S.Mo. (1992 Supp.) and for no other purposes whatsoever, Nineteen Thousand Dollars
4 (\$19,000) from Sheriff's Auction proceeds, Nine Hundred Thousand Dollars (\$900,000) in
5 payments from the Land Reutilization Authority, One Hundred Ten Thousand Dollars (\$110,000)
6 in released TIF fund revenues, Six Million, Seventy-Eight Thousand Dollars (\$6,078,000) from
7 the City Employee Pension Trust Fund for purposes set forth in Ordinance No. 67815, and
8 authorizing and directing the Collector of Revenue, pursuant to §67.657.9 R.S.Mo. (1992 Supp.),
9 by contract or otherwise, to collect the taxes authorized under the provisions of §67.657.8 R.S.Mo.
10 (1992 Supp.), and notwithstanding ordinance 69202, One Million, Three Hundred Twenty
11 Thousand Dollars (\$1,320,000) as the estimated 60% of Certificate of Inspection revenues
12 previously allocated to the Lead Remediation Fund, and Five Million Dollars (\$5,000,000) in
13 interest earnings from the American Rescue Plan Act funds. The aforementioned sums to be
14 utilized for the Support, Maintenance and Operations of the Several Departments, Boards, Offices,
15 etc. of the City Government for the ensuing year as hereinafter detailed.

18 There is hereby appropriated One Million, Seven Hundred Seventy-Two Thousand, Four Hundred
19 Fifty-One Dollars (\$1,772,451) in Police Department receipts from various agencies for providing
20 police services on a contractual basis with those agencies.

21 **FUND 1002 COMMUNICATIONS FUND**

1 There is hereby appropriated and set apart the sum of One Million, Three Hundred Fourteen
2 Thousand, Seven Hundred Forty-Five Dollars (\$1,314,745) from the Communications Division
3 Fund and anticipated revenues for the operations and expenses of the COMMUNICATIONS
4 DIVISION-DEPARTMENT OF PUBLIC UTILITIES, and Ninety-Seven Thousand, Nine
5 Hundred Ten Dollars (\$97,910) from projected rental payments from wireless service providers
6 for deployment of small wireless facilities in the City Right of Way pursuant to Ordinance Number
7 70892 as hereinafter detailed.

8 **FUND 1110 LOCAL USE TAX TRUST FUNDS**

9 There is hereby appropriated and set apart out of accrued local use tax revenues and local use tax
10 revenues allocated under the provisions of Ordinance No. 65609 the following: Six Million, Five
11 Hundred Thirteen Thousand, One Hundred Seventy-Five Dollars (\$6,513,175) from the
12 AFFORDABLE HOUSING TRUST to the AFFORDABLE HOUSING COMMISSION for
13 providing for the development and preservation of affordable and accessible housing, Five Million,
14 One Hundred Seventy-One Thousand, Seven Hundred Fifty-Eight Dollars (\$5,171,758) from the
15 HEALTH CARE TRUST FUND for public health care services, Three Million Dollars
16 (\$3,000,000) from the USE TAX DEMOLITION FUND to the BUILDING COMMISSIONER
17 for demolition of derelict buildings and Fifty-Two Million, Seven Hundred Forty Thousand, Fifty-
18 One Dollars (\$52,740,051) from the USE TAX EXCESS TRUST FUND consisting of Thirteen
19 Million, Thirty-Five Thousand, Nine Hundred Seventy Dollars (\$13,035,970) for public health
20 care services of the DEPARTMENT OF HEALTH AND HOSPITALS, Two Million, Nine
21 Hundred Thirty-Eight Thousand, Two Hundred Eighty-Four Dollars (\$2,938,284) and Nine
22 Hundred Sixty-Three Thousand, Four Hundred Seventeen Dollars (\$963,417) for neighborhood

1 preservation efforts of the BUILDING DIVISION and REFUSE DIVISION respectively,
2 Twenty-One Million, Four Hundred Twenty-Seven Thousand, Three Hundred Dollars
3 (\$21,427,300) for public safety efforts of the POLICE DEPARTMENT, Six Hundred Seventy-
4 Five Thousand Dollars (\$675,000) and Two Million, Six Hundred Fifty Thousand Dollars
5 (\$2,650,000) for estimated firefighter & police pension costs respectively, Eight Million, Seven
6 Hundred Thirty-Five Thousand, Two Hundred Twenty-Nine Dollars (\$8,735,229) for the office of
7 Violence Prevention, One Million, Six Hundred Twenty-Nine Thousand, Seven Hundred Forty-
8 Two Dollars (\$1,629,742) for emergency housing Administrative Services of the DEPARTMENT
9 OF HUMAN SERVICES, and Six Hundred Eighty-Five Thousand, One Hundred Nine Dollars
10 (\$685,109) for the Affirmative Litigation Unit of the City Counselor's Office

11 **FUND 1111 MISCELLANEOUS SPECIAL FUNDS**

12 There is hereby appropriated and set apart the sum of Eighty Thousand, Two Hundred Twenty-
13 Five Dollars (\$80,225) from philanthropic organization revenue to the Office of the Mayor for
14 funding a position within the office, One Million, Six Hundred Forty-Six Thousand, Four Hundred
15 Twenty-Three Dollars (\$1,646,423) from Administrative Fee Charges to departments for
16 operations of the Benefits Section of the Department of Personnel, Six Million, Seventy-Eight
17 Thousand Dollars (\$6,078,000) in telephone gross receipts tax revenues for the City Employee
18 Pension Trust Fund for purposes set forth by Ordinance No. 67815 revenues accruing to the
19 Employee Pension Trust Fund in excess of the appropriated amount may be remitted to the General
20 Fund for purposes consistent with the ordinance, Six Hundred Sixty-Six Thousand, Four Hundred
21 Eighty-Five Dollars (\$666,485) in Building Demolition Fund Revenues for the Problem Properties
22 Unit of the CITY COUNSELOR'S OFFICE, Two Million, Two Hundred Eighty-Eight Thousand,

1 Seventy Dollars (\$2,288,070) in rent revenues and subsidies to the COMPTROLLER’S OFFICE
2 for the operation of the Gateway Transportation Center, Two Million, One Hundred Fifty-Four
3 Thousand, One Hundred Fifty-Three Dollars (\$2,154,153) in TIF Revenues for TIF administrative
4 costs of the Comptroller’s Office, Three Million, Three Hundred Eight Thousand, Seven Hundred
5 Seventy Dollars (\$3,308,770) received into the FOREST PARK FUND for improvements to
6 Forest Park and consistent with Ordinance 64437 whereas one of the “funding sources policies”
7 approved by the Board of Aldermen and adopted by the Community Development Commission in
8 Section 2.4 of the Goals and Policies called upon the City to “Consider applying all revenue
9 generated from Forest Park to activities, improvements and operations within Forest Park”,
10 provided however that the Round Up funds appropriated by this ordinance shall only be expended
11 for a project, or projects, proposed by the Director of Parks, Recreation and Forestry and approved
12 by resolution of the Committee on Parks & Environmental Affairs of the Board of Aldermen
13 pursuant to Ordinance 62196, which is codified as Chapter 5.76 R.C., 1994, Annotated, Six
14 Hundred Thirteen Thousand Dollars (\$613,000) in reimbursement payments to the Forest Park
15 Fund for Forest Park maintenance efforts of the Parks Department, One Hundred Forty-Six
16 Thousand, One Hundred Eighty-Two Dollars (\$146,182) from special revenues related to
17 Lafayette Square Park for Park Maintenance efforts of the PARKS DEPARTMENT, Three
18 Hundred Seventy-One Thousand, Eight Fifty-Four Dollars (\$371,854) from private sources for
19 Forest Park maintenance efforts of the FORESTRY DIVISION. Fifty Thousand (\$50,000) in
20 Special Demolition Funds, to the Forestry Division for hazardous tree removal, Fifteen Thousand
21 (\$15,000) to the Parks Division from Downtown Vending Fee Funds, One Million, Nine Hundred
22 Fourteen Thousand, Six Hundred Eleven Dollars (\$1,914,611) out of the PARENT LOCATOR

1 FUND for the operation of the CHILD SUPPORT UNIT of the Circuit Attorney's Office, Three
2 Thousand, Six Hundred Dollars (\$3,600) for the CIRCUIT ATTORNEY'S TRAINING FUND,
3 One Hundred Eighty-Four Thousand, Seven Hundred Sixteen Dollars (\$184,716) from revenues
4 generated by the Circuit Attorney from the collection of delinquent taxes to fund the collection
5 effort, Four Hundred Seventy-One Thousand, Eight Hundred Ninety-Six Dollars (\$471,896) from
6 revenues generated by the OFFICE OF THE PUBLIC ADMINISTRATOR for services performed
7 by that office, Five Hundred Thirty-Three Thousand, Two Hundred Eight Dollars (\$533,208) from
8 CHILDREN SERVICES FUND revenues for programs for juveniles at the Juvenile Division of
9 the 22nd JUDICIAL CIRCUIT COURT, Five Hundred Ninety-Two Thousand, Three Hundred

11 Ordinance No. 70057 for the operation of the TREASURER'S OFFICE OF EMPOWERMENT,

16 from fees generated by the Street Excavation Restoration Program for the STREETS
17 DEPARTMENT to be used solely for materials and equipment required to properly seal pavement
18 joints following street excavations, Two Hundred Thirty-Two Thousand, Eight Hundred Eighty-
19 One Dollars (\$232,881) from the Metro Trash Fund for Refuse Division Trash Collection at Metro
20 Facilities, Two Million, Six Hundred Fifty-Five Thousand Dollars (\$2,655,000) from Improved
21 Wharf Fund revenues to fund the PORT AUTHORITY Budget, Seven Million, Nine Hundred

6 of Lead Remediation Efforts, Four Fifty Thousand Dollars (\$450,000) from Jail Facilities funds
7 for improvements at the CITY JUSTICE CENTER, One Hundred Thirty-Seven Thousand, Two
8 Hundred Dollars (\$137,200) from building code violation fees for vacant building enforcement
9 initiatives of the BUILDING DIVISION, One Million, Ninety-Five Thousand Dollars
10 (\$1,095,000) from telephone commissions of Corrections Division for Corrections Division
11 Program Expenses, Fifty Thousand Dollars (\$50,000) from revenues received pursuant to
12 Ordinance No. 61294 and deposited into the Police Training Fund Account for the sole purpose of
13 training of peace officers, One Hundred Twenty Thousand Dollars (\$120,000) which appropriation
14 consists of One Hundred Thousand Dollars (\$100,000) from court costs pursuant to Ordinance
15 62751, for the purpose of providing operating expenses for shelters to battered persons and Twenty
16 Thousand Dollars (\$20,000) from Marriage and Marriage Dissolution Fees pursuant to Ordinance
17 58745 for the purpose of providing financial assistance to shelter for victims of domestic violence
18 pursuant to Section 455.000 to 455.230, R.S.Mo., 1996, Five Hundred Seventy-Four Thousand,
19 One Hundred Six Dollars (\$574,106) in building violation fine and fee revenue with One Hundred
20 Thousand Six Hundred Twenty-Four Dollars (\$100,624) to the City Counselor's Office, Three
21 Hundred Twenty-Seven Thousand Five Hundred (\$327,500) to the Community Development
22 Agency and One Hundred Forty-Five Thousand, Nine Hundred Eighty-Two Dollars (\$145,982) to

1 the Building Division for activities pursuant to Ordinance No. 71990 pertaining to the Vacant
2 building Initiative II, and Two Million, Nine Hundred Thirty-Six Thousand, Three Hundred
3 Eighty-Seven Dollars (\$2,936,387) received pursuant to the provisions of Ordinance No. 62830
4 and other revenues deposited into the Building Demolition Fund to be used to finance demolition
5 and board up of dangerous buildings, notwithstanding, the provisions of Ordinance 62830, the
6 Building Commissioner is hereby authorized to expend monies by contract or otherwise for the
7 purposes set forth in Ordinance 62830 and to effect transfers between accounts in Fund 1111,
8 Department 620 for the purpose of providing for necessary operating expenses of the Building
9 Division in accordance with the transfer provisions of this Ordinance and in addition to the above
10 appropriation, any funds received subject to refund pursuant to Ordinance No. 63838 are to be
11 refunded according to the provisions of said ordinance.

12 **FUND 1112 RIVERFRONT GAMING FUND**

13 There is hereby appropriated and set apart the sum of Four Million, Six Hundred Ninety-Three
14 Thousand Dollars (\$4,693,000) out of revenues received from fees pursuant to §313.820 and
15 §313.822 R.S. Mo. for the purposes of providing for the safety of the public visiting excursion
16 gambling boats, and the purchase of capital equipment and improvements, as hereinafter detailed.

17 **FUND 1113 CONVENTION AND TOURISM FUNDS**

18 There is hereby appropriated and set apart out of revenues derived from taxes and license fees
19 under Ordinance No. 56263, and other revenues deposited to the Tourism Fund, the sum of Seven
20 Million, Eight Hundred Seventy-Five Thousand Dollars (\$7,875,000) for expenditure by the
21 CONVENTION AND TOURISM BUREAU for the purposes listed in Section 3.64.020 of the
22 Revised Code of the City of St. Louis, 1980 Annotated; provided, however, that any contract

1 approved by the Convention and Tourism Bureau providing for payment to any one corporation
2 or organization in excess of or aggregating in excess of \$100,000 during any one fiscal year of the
3 City shall be subject to the concurrence of the St. Louis Board of Aldermen, which concurrence
4 shall be evidenced by resolution of such Board adopted after request of the Convention and
5 Tourism Bureau, or by specific inclusion in this Budget Ordinance. There is hereby appropriated
6 and set apart the sum of Eleven million, Two Hundred Thousand Dollars (\$11,200,000) from the
7 funds deposited in the City CONVENTION and SPORTS FACILITY TRUST FUND, for the
8 purposes set forth in §67.657.10 R.S.Mo. (1992 Supp.) and for no other purpose whatsoever.
9 Revenues accruing to the Convention and Sports Facility Trust Fund in excess of the appropriated
10 amount may be remitted to the General Fund for purposes consistent with the statute up to the
11 amount of excess revenues available.

12 **FUND 1115 ASSESSMENT FUND**

13 There is hereby appropriated and set apart for the Assessor's Office the sum of Five Million, Four
14 Hundred Eighty-One Thousand, Eighty-Nine Dollars (\$5,481,089) which appropriation consists
15 of Three Million, Seven Hundred Eighty-One Thousand, Eighty-Nine Dollars (\$3,781,089) from
16 the ASSESSMENT FUND and One Million, Seven Hundred Thousand Dollars (\$1,700,000) from
17 the General Fund Appropriation.

18 **FUND 1116 PUBLIC SAFETY TRUST FUND**

19 There is hereby appropriated out of Graduated Business License Tax revenues allocated according
20 to the provisions of Ordinance 67193 the following: Three Hundred Sixty-Six Thousand, Eight
21 Hundred Sixty-Seven Dollars (\$366,867) for enhanced, and notwithstanding Ordinance 67193,
22 existing problem properties and nuisance crime prosecution efforts of the CITY COUNSELOR'S

OFFICE, Eight Hundred Seventy-Three Thousand, Two Hundred Fifty-Five Dollars (\$873,255) for enhanced criminal prosecution efforts of the CIRCUIT ATTORNEY’S OFFICE, and Two Million, Five Hundred Thirty-Four Thousand Dollars (\$2,534,000) for enhanced police services and notwithstanding Ordinance 67193 other operations of the POLICE DEPARTMENT.

FUND 1117 LATERAL SEWER FUND

There is hereby appropriated and set apart out of anticipated revenues to the Lateral Sewer Fund the sum of Two Million, Eight Hundred Eighty-Five Thousand, Four Hundred Sixty-Three Dollars (\$2,885,463) for the operations and expenses of the Lateral Sewer Program.

FUND 1118 SPECIAL PARK FUNDS

There is hereby appropriated and set apart from revenues in the Local Parks Fund, Five Million, Six Hundred thirty-Five Thousand, Three Hundred Fifty-Four Dollars (\$5,635,354) to the DIRECTOR OF PARKS for the purpose of funding construction and maintenance of new and existing recreation centers and Parks and Recreation programs pursuant to Ordinance No. 67195.

There is hereby appropriated and set apart from payments from general revenue into the Neighborhood Parks Fund to the DIRECTOR OF PARKS for park improvements, Two Million, Six Hundred Thousand, Nine Hundred Sixty-Nine Dollars (\$2,600,969). There is hereby appropriated and set apart from revenues deposited into the BJC/City Trust Fund, Two Million, Six Hundred Thirteen Thousand, Nine Hundred Forty-Five Dollars (\$2,613,945) to the DIVISION OF PARKS for maintenance of Forest Park pursuant to Ordinance No. 67477, and Twenty-Five Thousand, Four Hundred Ninety-Nine Dollars (\$25,499) from miscellaneous recreation center fees to the DEPARTMENT OF RECREATION for the purpose of funding City recreation centers.

FUND 1119 CITY PUBLIC SAFETY PROTECTION SALES TAX FUND

1 There is hereby appropriated and set apart from revenues in the City Public Safety Protection Sales
2 Tax Fund per Ordinance 67794 Twenty-Two Thousand, Eight Hundred Nineteen Thousand, Two
3 Hundred Dollars (\$22,819,200) consisting of Five Million, Five Hundred Thousand Dollars
4 (\$5,500,000) for police pensions and Five Million, Five Hundred Thousand Dollars (\$5,500,000)
5 for firefighters' pensions in the Public Safety Pension Trust Sub-Account, Four Million, Five
6 Hundred Thousand Dollars (\$4,500,000) and One Million, Six Hundred Twenty-Five Thousand
7 Dollars (\$1,625,000) for costs of FY09 salary increases for police and police civilian employees
8 of the Police Department and firefighters respectively, Four Million, Six Hundred Ninety-Four
9 Thousand, Two Hundred Dollars (\$4,694,200) for a portion of the costs of compensating and
10 providing benefits including pension funding for that number of new police officers, as provided

19 67.1305 R.S.Mo and further specified in Ordinance No. 70435 as hereinafter detailed.

20 **FUNDS 1121 PUBLIC SAFETY SALES AND USE TAX FUND**

21 There is hereby appropriated out of sales and use taxes received into the Public Safety Sales and
22 Use Tax Fund, the sum of Thirty-Five Million, Two Hundred Twenty-Two Thousand, Ninety-

Four Dollars (\$35,222,094) for the purposes set forth in Ordinance No. 70580 as hereinafter detailed.

FUND 1205 CAPITAL IMPROVEMENT PROJECTS FUND

Pursuant to Ordinance No. 60419, there is hereby appropriated and set apart the sum of Thirty-Three Million, Eight Hundred Eighty-Four Thousand, Two Hundred Dollars (\$33,884,200) from Capital Fund sources as follows: Two Million, Five Hundred Twenty-Five Thousand, Five Hundred Dollars (\$2,525,500) in transfers from the General Fund, One Million Dollars (\$1,000,000) from Courthouse Restoration Funds, Five Million, Three Hundred Twenty-Five Thousand, Dollars (\$5,325,000) from the state gasoline tax for improvements of streets and bridges, Two Million, Four Hundred One Thousand, Seven Hundred Dollars (\$2,401,700) from the Economic Development Sales Tax Fund, Two Hundred Thousand Dollars (\$200,000) from the Riverfront Gaming Fund, One Hundred Eighty-Five Thousand Dollars (\$185,000) from Municipal Garage Revenue, and Four Hundred Thousand Dollars (\$400,000) in rent from City owned property on Central Industrial Drive, Six Hundred Fifty Thousand Dollars (\$650,000) from prior year unappropriated Capital Balances, \$21,197,000 as the one half of the General Fund operating surplus from the prior year, all for the purchase of capital equipment and improvements, as detailed in **Exhibit A** and authorizing the Board of E & A to enter into Lease Purchase agreements for various assets in an amount not to exceed Thirty Five Million Dollars (\$35,000,000) subject to annual appropriation for a term not to exceed ten years, to expend such amounts for various assets including capital equipment and building improvements and granting a security interest and providing for maintenance and pre-payment in the event of default and providing for such other and reasonable, customary terms as necessary. Notwithstanding the provisions of Ordinance No.

60419 as amended by Ordinance No. 61250, the Capital Fund amount of one-half of any General Fund balance from the immediately preceding fiscal year credited to the Capital Fund shall be interpreted as one-half of the General Fund operating balance, provided that such operating balance is greater than zero, of the immediately preceding fiscal year. 1 in the 14 Wards of the City, Three Million, Five Hundred Seventy-Six Thousand, Eight Hundred
2 Dollars (\$3,576,800) for capital improvements in major and citywide parks, Six Hundred Thirty-
3 One Thousand, Two Hundred Dollars (\$631,200) for Capital Improvements in Recreation Centers,
4 Two Million, One Hundred Four Thousand Dollars (\$2,104,000) for debt service payments and,
5 notwithstanding the provisions of Section Nine of Ordinance No. 62885, other capital

There is hereby appropriated and set apart all funds deposited in the Special Allocation Fund for PILOTS Account and 50% Economic Activities Taxes (EATS) Account to be used in accordance with the Application for the St. Louis Innovation District RPA7 SSTIF (State Supplemental Tax Increment Financing).

FUND 2001 WATER DIVISION ENTERPRISE FUND

There is hereby appropriated and set apart out of the Waterworks Revenue and from Various Accounts as set forth in Section Six (a), (b), (c), (d), and (e) of Ordinance No. 49382 approved March 20, 1955, and Ordinance No. 51378 approved June 22, 1962, and Ordinance No. 55581 approved April 2, 1979, the sum of Eighty-Nine, Million, Two Hundred Twenty-Eight Thousand, Six Hundred Thirty-Eight Dollars (\$89,228,638) for the WATER DIVISION.

FUND 2003 THE CITY OF ST. LOUIS AIRPORT ENTERPRISE FUND

There is hereby appropriated and set apart out of Airport Revenue from the Various Accounts set forth in Section 11 (a), (b), (c), (d), and (e) of Ordinance No. 54999 approved March 19, 1968, the sum of Two Hundred Forty-Eight Million, Nine Hundred Thirty Thousand, Seven Hundred Seventy-Seven Dollars (\$248,930,777) for the CITY OF ST. LOUIS AIRPORT COMMISSION.

FUND 2101 CENTRALIZED MAILROOM INTERNAL SERVICE FUND

There is hereby appropriated and set apart from revenues received for mailroom services and from line item appropriations contained within this ordinance, the sum of Eight Hundred Twenty-Nine Thousand, Seven Hundred Eighty Dollars (\$829,780) for the operations of the Centralized Mail Room as an internal service fund.

FUND 2102 EQUIPMENT SERVICES INTERNAL SERVICE FUND

The is hereby appropriated and set apart from revenues received from providing fuel to various city departments and agencies from line item appropriations contained within this ordinance, the

sum of Six Million, Five Hundred Twenty-Six Thousand, Six Hundred Forty-Two Dollars (\$6,526,642) for the purchase of gasoline and diesel fuel and related operations of the EQUIPMENT SERVICES DIVISION internal service fund.

FUND 2103 CITY EMPLOYEES' HEALTH INSURANCE PLAN FUND

There is hereby appropriated and set apart from funds deposited into the CITY EMPLOYEES' HEALTH AND HOSPITAL PLAN FUNDS the sum of Twenty Nine Million, One Hundred Sixty Three Thousand, Five Dollars (\$29,163,500) for the operations of the Employee Benefits Section of the Department of Personnel.

FUND 2105 POLICE INTERNAL SERVICE FUND

There is hereby appropriated Sixteen Million, Four Hundred Fourteen Thousand, Eight Hundred Ninety-Nine Dollars (\$16,414,899) from revenues received from the St. Louis Metropolitan Police Department for support services provided to the department consisting of Four Hundred Twenty-Nine Thousand, One Hundred Seventy-Four Dollars (\$429,174) for the Department of Personnel, Five Million, Six Hundred Twenty-Nine Thousand, Two Hundred Seventy-One Dollars (\$5,629,271) for the City Counselor's Office, Five Million, Four Hundred Eighty Thousand, Nine Hundred Fifty-One Dollars (\$5,480,951) and Four Million, Eight Hundred Seventy-Five Thousand, Five Hundred Three Dollars (\$4,875,503) for operations of the Facilities Management and Equipment Services Divisions of the Board of Public Service.

SECTION FIVE.

Pursuant to §393.275 R.S.Mo., 2000, the tax rate of any business license tax on the gross receipts of utility corporations imposed pursuant to Ordinances No. 58976 and No. 58977 shall be maintained at the rates provided in such ordinances.

1 **SECTION SIX.**

2 Funds appropriated to Department 190-City Wide Accounts for contractual services shall not be
3 expended without specific approval of that purpose by the Board of Estimate and Apportionment.
4 Such approval shall be evidenced by a majority vote of said Board for each specific expenditure.
5 Such approval by said Board shall be required in addition to the Board's approval of this budget
6 ordinance.

7 **SECTION SEVEN.**

8 By this ordinance, the Comptroller is directed to cause to be made any appropriation transfer within
9 or between or among departments or divisions or funds if such transfers are not more than
10 \$250,000 per occurrence and if they are approved by a majority of the Board of Estimate and
11 Apportionment. For those transfers within a department or division that are between or among
12 accounts in a single account group, the transfers may be made without prior approval of the Board
13 of Estimate and Apportionment, if not more than \$250,000 per occurrence and if approved by the
14 Comptroller and Budget Director. Single account groups for these purposes shall be limited to the
15 following: materials and supplies, rental and non-capital leases, non-capital equipment, capital
16 assets and contractual and other services.

17 **SECTION EIGHT.**

18 The Comptroller is hereby authorized to pay obligations incurred prior to July 1, 2025 from
19 previously appropriated funds which have been set aside for the purpose of honoring legally
20 incurred obligations and identified as a reserve for prior year encumbrances and commitments.

21 **SECTION NINE.**

1 Departments with miscellaneous Contractual Services accounts are hereby authorized to enter into
2 contracts for purposes related to the conduct of business of their departments. Departments with
3 contractual service accounts for office and other equipment are hereby authorized to enter into
4 such contracts for repairs to all types of equipment including but not limited to telephones, copiers,
5 fax machines, computers and printers.

6 **SECTION TEN**

7 The Law Department is hereby authorized to expend, and to enter into contracts, settlements, and
8 other documents, which are hereby approved, for the purpose of expending appropriations to the
9 Judgement Fund for the management of litigation and workers' compensation claims, including
10 the settling of claims and demands, paying judgments, costs and expenses for litigation, and
11 attorneys' fees.

12 **SECTION ELEVEN**

13 This being a general appropriations ordinance and an ordinance making an appropriation for the
14 payment of principal and interest of the public debt and for the current expenses of the City, it is
15 an emergency measure within the meaning of Sections 19 and 20 of Article IV of the Charter of
16 the City of St. Louis and therefore this ordinance shall become effective immediately upon its
17 passage and approval by the Mayor.

1 There is hereby appropriated and set apart the sum of One Million, Three Hundred Fourteen
2 Thousand, Seven Hundred Forty-Five Dollars (\$1,314,745) from the Communications Division
3 Fund and anticipated revenues for the operations and expenses of the COMMUNICATIONS
4 DIVISION-DEPARTMENT OF PUBLIC UTILITIES, and Ninety-Seven Thousand, Nine
5 Hundred Ten Dollars (\$97,910) from projected rental payments from wireless service providers
6 for deployment of small wireless facilities in the City Right of Way pursuant to Ordinance Number
7 70892 as hereinafter detailed.

15 Twenty-Three Dollars (\$1,646,423) from Administrative Fee Charges to departments for
16 operations of the Benefits Section of the Department of Personnel, Six Million, Seventy-Eight
17 Thousand Dollars (\$6,078,000) in telephone gross receipts tax revenues for the City Employee
18 Pension Trust Fund for purposes set forth by Ordinance No. 67815 revenues accruing to the

18 There is hereby appropriated and set apart out of revenues derived from taxes and license fees
19 under Ordinance No. 56263, and other revenues deposited to the Tourism Fund, the sum of Seven
20 Million, Eight Hundred Seventy-Five Thousand Dollars (\$7,875,000) for expenditure by the
21 CONVENTION AND TOURISM BUREAU for the purposes listed in Section 3.64.020 of the
22 Revised Code of the City of St. Louis, 1980 Annotated; provided, however, that any contract

1 approved by the Convention and Tourism Bureau providing for payment to any one corporation
2 or organization in excess of or aggregating in excess of \$100,000 during any one fiscal year of the
3 City shall be subject to the concurrence of the St. Louis Board of Aldermen, which concurrence
4 shall be evidenced by resolution of such Board adopted after request of the Convention and
5 Tourism Bureau, or by specific inclusion in this Budget Ordinance. There is hereby appropriated
6 and set apart the sum of Eleven million, Two Hundred Thousand Dollars (\$11,200,000) from the
7 funds deposited in the City CONVENTION and SPORTS FACILITY TRUST FUND, for the
8 purposes set forth in §67.657.10 R.S.Mo. (1992 Supp.) and for no other purpose whatsoever.
9 Revenues accruing to the Convention and Sports Facility Trust Fund in excess of the appropriated
10 amount may be remitted to the General Fund for purposes consistent with the statute up to the
11 amount of excess revenues available.

13 There is hereby appropriated and set apart for the Assessor's Office the sum of Five Million, Four
14 Hundred Eighty-One Thousand, Eighty-Nine Dollars (\$5,481,089) which appropriation consists
15 of Three Million, Seven Hundred Eighty-One Thousand, Eighty-Nine Dollars (\$3,781,089) from
16 the ASSESSMENT FUND and One Million, Seven Hundred Thousand Dollars (\$1,700,000) from
17 the General Fund Appropriation.

18 **FUND 1116 PUBLIC SAFETY TRUST FUND**

19 There is hereby appropriated out of Graduated Business License Tax revenues allocated according
20 to the provisions of Ordinance 67193 the following: Three Hundred Sixty-Six Thousand, Eight
21 Hundred Sixty-Seven Dollars (\$366,867) for enhanced, and not withstanding Ordinance 67193,
22 existing problem properties and nuisance crime prosecution efforts of the CITY COUNSELOR'S

OFFICE, Eight Hundred Seventy-Three Thousand, Two Hundred Fifty-Five Dollars (\$873,255) for enhanced criminal prosecution efforts of the CIRCUIT ATTORNEY’S OFFICE, and Two Million, Five Hundred Thirty-Four Thousand Dollars (\$2,534,000) for enhanced police services and notwithstanding Ordinance 67193 other operations of the POLICE DEPARTMENT.

FUND 1117 LATERAL SEWER FUND

There is hereby appropriated and set apart out of anticipated revenues to the Lateral Sewer Fund the sum of Two Million, Eight Hundred Eighty-Five Thousand, Four Hundred Sixty-Three Dollars (\$2,885,463) for the operations and expenses of the Lateral Sewer Program.

FUND 1118 SPECIAL PARK FUNDS

There is hereby appropriated and set apart from revenues in the Local Parks Fund, Five Million, Six Hundred thirty-Five Thousand, Three Hundred Fifty-Four Dollars (\$5,635,354) to the DIRECTOR OF PARKS for the purpose of funding construction and maintenance of new and existing recreation centers and Parks and Recreation programs pursuant to Ordinance No. 67195.

There is hereby appropriated and set apart from payments from general revenue into the Neighborhood Parks Fund to the DIRECTOR OF PARKS for park improvements, Two Million, Six Hundred Thousand, Nine Hundred Sixty-Nine Dollars (\$2,600,969). There is hereby appropriated and set apart from revenues deposited into the BJC/City Trust Fund, Two Million, Six Hundred Thirteen Thousand, Nine Hundred Forty-Five Dollars (\$2,613,945) to the DIVISION OF PARKS for maintenance of Forest Park pursuant to Ordinance No. 67477, and Twenty-Five Thousand, Four Hundred Ninety-Nine Dollars (\$25,499) from miscellaneous recreation center fees to the DEPARTMENT OF RECREATION for the purpose of funding City recreation centers.

FUND 1119 CITY PUBLIC SAFETY PROTECTION SALES TAX FUND

1 There is hereby appropriated and set apart from revenues in the City Public Safety Protection Sales
2 Tax Fund per Ordinance 67794 Twenty-Two Thousand, Eight Hundred Nineteen Thousand, Two
3 Hundred Dollars (\$22,819,200) consisting of Five Million, Five Hundred Thousand Dollars
4 (\$5,500,000) for police pensions and Five Million, Five Hundred Thousand Dollars (\$5,500,000)
5 for firefighters' pensions in the Public Safety Pension Trust Sub-Account, Four Million, Five
6 Hundred Thousand Dollars (\$4,500,000) and One Million, Six Hundred Twenty-Five Thousand
7 Dollars (\$1,625,000) for costs of FY09 salary increases for police and police civilian employees
8 of the Police Department and firefighters respectively, Four Million, Six Hundred Ninety-Four
9 Thousand, Two Hundred Dollars (\$4,694,200) for a portion of the costs of compensating and
10 providing benefits including pension funding for that number of new police officers, as provided
11 by law, which would result in a police force of approximately One Thousand Four Hundred (1,400)

19 67.1305 R.S.Mo and further specified in Ordinance No. 70435 as hereinafter detailed.

20 **FUNDS 1121 PUBLIC SAFETY SALES AND USE TAX FUND**

21 There is hereby appropriated out of sales and use taxes received into the Public Safety Sales and
22 Use Tax Fund, the sum of Thirty-Five Million, Two Hundred Twenty-Two Thousand, Ninety-

Four Dollars (\$35,222,094) for the purposes set forth in Ordinance No. 70580 as hereinafter detailed.

FUND 1205 CAPITAL IMPROVEMENT PROJECTS FUND

Pursuant to Ordinance No. 60419, there is hereby appropriated and set apart the sum of Thirty-Three Million, Eight Hundred Eighty-Four Thousand, Two Hundred Dollars (\$33,884,200) from Capital Fund sources as follows: Two Million, Five Hundred Twenty-Five Thousand, Five Hundred Dollars (\$2,525,500) in transfers from the General Fund, One Million Dollars (\$1,000,000) from Courthouse Restoration Funds, Five Million, Three Hundred Twenty-Five Thousand, Dollars (\$5,325,000) from the state gasoline tax for improvements of streets and bridges, Two Million, Four Hundred One Thousand, Seven Hundred Dollars (\$2,401,700) from the Economic Development Sales Tax Fund, Two Hundred Thousand Dollars (\$200,000) from the Riverfront Gaming Fund, One Hundred Eighty-Five Thousand Dollars (\$185,000) from Municipal Garage Revenue, and Four Hundred Thousand Dollars (\$400,000) in rent from City owned property on Central Industrial Drive, Six Hundred Fifty Thousand Dollars (\$650,000) from prior year unappropriated Capital Balances, \$21,197,000 as the one half of the General Fund operating surplus from the prior year, all for the purchase of capital equipment and improvements, as detailed in **Exhibit A** and authorizing the Board of E & A to enter into Lease Purchase agreements for various assets in an amount not to exceed Thirty Five Million Dollars (\$35,000,000) subject to annual appropriation for a term not to exceed ten years, to expend such amounts for various assets including capital equipment and building improvements and granting a security interest and providing for maintenance and pre-payment in the event of default and providing for such other and reasonable, customary terms as necessary. Notwithstanding the provisions of Ordinance No.

60419 as amended by Ordinance No. 61250, the Capital Fund amount of one-half of any General Fund balance from the immediately preceding fiscal year credited to the Capital Fund shall be interpreted as one-half of the General Fund operating balance, provided that such operating balance is greater than zero, of the immediately preceding fiscal year. Furthermore, notwithstanding the provisions of Ordinance No. 60419 as amended by Ordinance No. 61250, the transfer of one-half of the General Fund operating balance from the preceding fiscal year shall be suspended if the unreserved general fund balance is below five percent of the general fund budget. The signatures of the President of the Board of Public Service, the Chair of the Capital Committee and the Comptroller shall be required for commitment of money from this fund.

FUND 1207 METRO PARKS SALES TAX FUND

There is hereby appropriated and set apart the sum of Five Million, One Hundred Thirty-Eight Thousand Dollars (\$5,138,000) from revenues received from the 1/10 cent Metro Parks Sales Tax, and from the 3/16 cent Metro Parks Sales Tax for park purposes including improvements, establishment, administration, operation and maintenance as detailed in **Exhibits H, I, J, and K**. Revenues accruing to the Forest Park sub-account of the Major Parks Capital Improvements account in excess of the appropriated amount shall be expended for improvements to Forest Park pursuant to Ordinance 69042 and the Forest Park Supplemental Maintenance Agreement.

There is hereby appropriated and set apart the sum of Twenty-Two Million, Three Hundred Forty Thousand Dollars (\$22,340,000) from revenues in the Capital Improvements Sales Tax Trust Fund, for the following purposes and in the following amounts, as detailed in **Exhibits B through G**, Ten Million, Five Hundred Twenty Thousand Dollars (\$10,520,000) for capital improvements

1 in the 14 Wards of the City, Three Million, Five Hundred Seventy-Six Thousand, Eight Hundred
2 Dollars (\$3,576,800) for capital improvements in major and citywide parks, Six Hundred Thirty-
3 One Thousand, Two Hundred Dollars (\$631,200) for Capital Improvements in Recreation Centers,
4 Two Million, One Hundred Four Thousand Dollars (\$2,104,000) for debt service payments and,
5 notwithstanding the provisions of Section Nine of Ordinance No. 62885, other capital
6 improvements related to the Police Department, Four Million, Two Hundred Eight Thousand
7 Dollars (\$4,208,000) for City wide capital improvements, One Million, Three Hundred Thousand
8 Dollars (\$1,300,000) for salaries and expenses of the DEPARTMENT OF THE PRESIDENT,
9 BOARD OF PUBLIC SERVICE and the DEPARTMENT OF STREETS for design and
10 engineering costs related to capital improvement projects. Notwithstanding the preceding
11 paragraph, and the provisions of Section Nine of Ordinance 62885, approved June 4, 1993, and
12 any other ordinance to the contrary, revenues in each of the sub-accounts for the Ward
13 Improvement Account of the Capital Improvements Account of the Capital Improvements Sales
14 Tax Trust Fund No. 1208, may be transferred, deposited and used only within another sub-account
15 of the Ward Improvement Account of the Capital Improvements Account of the Capital
16 Improvements Sales Tax Trust Fund 1208, for purposes and uses as required by ordinance 62885,
17 upon the recommendation of the Alderpersons of the Wards which sub-accounts will be so
18 transferred and deposited, and upon the recommendation and approval of the Board of Estimate
19 and Apportionment. Revenues accruing to the Forest Park sub-account of the Major Parks Capital
20 Improvements account in excess of the appropriated amount shall be expended for improvements
21 to Forest Park pursuant to Ordinance 69042 and the Forest Park Supplemental Maintenance
22 Agreement.

FUND 1302 TRUSTEE LEASE FUND

There is hereby appropriated and set apart from funds on deposit in Trustee Lease accounts including funds transferred into this fund for payment of pension debt obligations, and revenues generated from such funds, the amount of Three Million, Eight Hundred Eighty-One Thousand, Four Hundred Thirty-Three Dollars (\$3,881,433) for payments on various lease debt agreements of the City, and for project costs as appropriate.

Additionally, revenues are appropriated from the 501 North Broadway Earnings and Payroll Tax Reimbursement Account", in an amount equal to fifty percent (50%) of the "Incremental Increase of earnings, payroll and net profit taxes generated by the developer in an amount in excess of \$915,000 per calendar year as and when received by the City, (as authorized by Ordinance 69035). Additionally, debt service is appropriated and maintained annually for Kiel Opera House from Peabody Opera House in the amount of \$250,000 of revenues from the 1.375% general fund sales tax. Additionally, revenues are appropriated and set apart in the Cheshire Inn Sales Tax Reimbursement Account in an amount equal to 50% of revenues received by the City from taxes imposed from the general municipal sales taxes, the capital improvement sales tax, the transportation sales tax, parks and recreation sales tax, public safety sales tax, the Restaurant Gross

1 Receipts Tax: all with any successor as authorized by Ordinance No. 68952. Additionally,
2 revenues are appropriated and set apart in the Union Station Sales Tax Reimbursement Account
3 in an amount equal to 50% of revenues received by the City from taxes imposed from the general
4 municipal sales taxes, the capital improvement sales tax, the transportation sales tax, parks and
5 recreation sales tax, public safety sales tax, the Restaurant Gross Receipts Tax; all with any
6 successor as authorized by Ordinance No. 69430. Additionally, revenues are appropriated and set
7 apart in the 705 Olive Sales Tax Reimbursement Account in an amount equal to 50% of revenues
8 received by the City from taxes imposed from the general municipal sales taxes, the capital
9 improvement sales tax, the transportation sales tax, parks and recreation sales tax, public safety
10 sales tax; all with any successor as authorized by Ordinance No. 70517, nor shall the maximum
11 reimbursement amount exceed \$2,300,000 or the aggregate amount of redevelopment project costs
12 identified on approved certificates of reimbursable redevelopment project costs.

13 **FUNDS 1501 THROUGH 1510 FEDERAL AND STATE GRANTS**

14 Funds appropriated by this ordinance as federal and state grants, identified as Fund #1501 through
15 Fund #1510, may be expended up to the amount of appropriation, subject only to the availability
16 of funds from the funding agencies. Fund 1509 American Rescue Plan Act Funds appropriated in
17 Ordinance #71505 from FY2023 are re-appropriated for the same purposes to the event balances
18 remain from the original appropriation.

19 **FUND 1509 ARPA INTEREST**

20 There is hereby appropriated Twenty-Two Million, One Hundred Twenty-Four Thousand, Seven
21 Hundred One Dollars (\$22,124,701) from existing interest earnings from ARPA account balances
22 with \$5,000,000 of this total allocated to the General Revenue Fund, Six Million, Eight Hundred

Seventy-Four Thousand, Seven Hundred One Dollars (\$6,874,701) allocated for capital improvements to the Circuit Court and Juvenile Detention Center buildings and Ten Million, Two Hundred Fifty Thousand Dollars (\$10,250,000) to be deposited into the City's judgement fund.

FUND 2001 WATER DIVISION ENTERPRISE FUND

There is hereby appropriated and set apart out of the Waterworks Revenue and from Various Accounts as set forth in Section Six (a), (b), (c), (d), and (e) of Ordinance No. 49382 approved March 20, 1955, and Ordinance No. 51378 approved June 22, 1962, and Ordinance No. 55581 approved April 2, 1979, the sum of Eighty-Nine, Million, Two Hundred Twenty-Eight Thousand, Six Hundred Thirty-Eight Dollars (\$89,228,638) for the WATER DIVISION.

FUND 2003 THE CITY OF ST. LOUIS AIRPORT ENTERPRISE FUND

There is hereby appropriated and set apart out of Airport Revenue from the Various Accounts set forth in Section 11 (a), (b), (c), (d), and (e) of Ordinance No. 54999 approved March 19, 1968, the sum of Two Hundred Forty-Eight Million, Nine Hundred Thirty Thousand, Seven Hundred Seventy-Seven Dollars (\$248,930,777) for the CITY OF ST. LOUIS AIRPORT COMMISSION.

FUND 2101 CENTRALIZED MAILROOM INTERNAL SERVICE FUND

There is hereby appropriated and set apart from revenues received for mailroom services and from line item appropriations contained within this ordinance, the sum of Eight Hundred Twenty-Nine Thousand, Seven Hundred Eighty Dollars (\$829,780) for the operations of the Centralized Mail Room as an internal service fund.

FUND 2102 EQUIPMENT SERVICES INTERNAL SERVICE FUND

The is hereby appropriated and set apart from revenues received from providing fuel to various city departments and agencies from line item appropriations contained within this ordinance, the

sum of Six Million, Five Hundred Twenty-Six Thousand, Six Hundred Forty-Two Dollars (\$6,526,642) for the purchase of gasoline and diesel fuel and related operations of the EQUIPMENT SERVICES DIVISION internal service fund.

FUND 2103 CITY EMPLOYEES' HEALTH INSURANCE PLAN FUND

There is hereby appropriated and set apart from funds deposited into the CITY EMPLOYEES' HEALTH AND HOSPITAL PLAN FUNDS the sum of Twenty Nine Million, One Hundred Sixty Three Thousand, Five Dollars (\$29,163,500) for the operations of the Employee Benefits Section of the Department of Personnel.

FUND 2105 POLICE INTERNAL SERVICE FUND

There is hereby appropriated Sixteen Million, Four Hundred Fourteen Thousand, Eight Hundred Ninety-Nine Dollars (\$16,414,899) from revenues received from the St. Louis Metropolitan Police Department for support services provided to the department consisting of Four Hundred Twenty-Nine Thousand, One Hundred Seventy-Four Dollars (\$429,174) for the Department of Personnel, Five Million, Six Hundred Twenty-Nine Thousand, Two Hundred Seventy-One Dollars (\$5,629,271) for the City Counselor's Office, Five Million, Four Hundred Eighty Thousand, Nine Hundred Fifty-One Dollars (\$5,480,951) and Four Million, Eight Hundred Seventy-Five Thousand, Five Hundred Three Dollars (\$4,875,503) for operations of the Facilities Management and Equipment Services Divisions of the Board of Public Service.

SECTION FIVE.

Pursuant to §393.275 R.S.Mo., 2000, the tax rate of any business license tax on the gross receipts of utility corporations imposed pursuant to Ordinances No. 58976 and No. 58977 shall be maintained at the rates provided in such ordinances.

1 **SECTION SIX.**

2 Funds appropriated to Department 190-City Wide Accounts for contractual services shall not be
3 expended without specific approval of that purpose by the Board of Estimate and Apportionment.
4 Such approval shall be evidenced by a majority vote of said Board for each specific expenditure.
5 Such approval by said Board shall be required in addition to the Board's approval of this budget
6 ordinance.

7 **SECTION SEVEN.**

8 By this ordinance, the Comptroller is directed to cause to be made any appropriation transfer within
9 or between or among departments or divisions or funds if such transfers are not more than
10 \$250,000 per occurrence and if they are approved by a majority of the Board of Estimate and
11 Apportionment. For those transfers within a department or division that are between or among
12 accounts in a single account group, the transfers may be made without prior approval of the Board
13 of Estimate and Apportionment, if not more than \$250,000 per occurrence and if approved by the
14 Comptroller and Budget Director. Single account groups for these purposes shall be limited to the
15 following: materials and supplies, rental and non-capital leases, non-capital equipment, capital
16 assets and contractual and other services.

17 **SECTION EIGHT.**

18 The Comptroller is hereby authorized to pay obligations incurred prior to July 1, 2025 from
19 previously appropriated funds which have been set aside for the purpose of honoring legally
20 incurred obligations and identified as a reserve for prior year encumbrances and commitments.

21 **SECTION NINE.**

1 Departments with miscellaneous Contractual Services accounts are hereby authorized to enter into
2 contracts for purposes related to the conduct of business of their departments. Departments with
3 contractual service accounts for office and other equipment are hereby authorized to enter into
4 such contracts for repairs to all types of equipment including but not limited to telephones, copiers,
5 fax machines, computers and printers.

6 **SECTION TEN**

7 The Law Department is hereby authorized to expend, and to enter into contracts, settlements, and
8 other documents, which are hereby approved, for the purpose of expending appropriations to the
9 Judgement Fund for the management of litigation and workers' compensation claims, including
10 the settling of claims and demands, paying judgments, costs and expenses for litigation, and
11 attorneys' fees.

12 **SECTION ELEVEN**

13 This being a general appropriations ordinance and an ordinance making an appropriation for the
14 payment of principal and interest of the public debt and for the current expenses of the City, it is
15 an emergency measure within the meaning of Sections 19 and 20 of Article IV of the Charter of
16 the City of St. Louis and therefore this ordinance shall become effective immediately upon its
17 passage and approval by the Mayor.
